Harry Boxer (ZYYI)

Site: TheTechTrader.com

Summary:

Harry Boxer chose Zynex, Inc. (ZYYI) which is a medical devices company based in Englewood, CO with a market cap of around \$300 million currently. In his presentation, Harry shows his chart for the last few years of various periods of consolidation and advancement. Harry explains that using Fibonacci analysis and historic levels that he's looking for a 50% or greater move over the next few months and provides more exact target levels and states that he believes the move could be much higher on a longer-term timeline.

Harry Boxer is a 50-year veteran trader and technical analyst, and author of the highly acclaimed Profitable Day & Swing Trading, noted by Stock Traders' Almanac as the 2015 Best Investment Book of the Year. Norman Hallett (AQUA)

Summary:

Norman Hallett chose Evoqua Water Technologies Corp. (AQUA) which is a water and wastewater treatment systems and technologies company based in Pittsburgh, PA with a market cap of almost \$4 billion currently. AQUA's water desalination and purification technologies are the main reasons why Norman is buying this stock for the long term. As with the gold rushes where the people who actually made the most money were those supplying shovels and other equipment to gold prospectors, Norman believes that AQUA's products put it in a similar position to profit from the growing need for clean water.

Bio:

Norman Hallett has been a trader and trading educator for over 4 decades. From 1981 to 1988, he ran one of the largest options firms in the country and later worked as a commodities specialist for Paine Webber. In 1991 he formed the Hallett Group, managing large trading accounts for individual investors as a Commodity Trading Advisor. He currently owns and operates The Disciplined Trader, founded in October, 2000, where he focuses on helping traders with the too-often-neglected area of mental and emotional control and the building of Simple Trading Plans. He has over a million views of his "4-Minute Drill For Traders" where he gives tips and techniques for being a more successful trader.

A.J. Brown (TEVA)

Summary:

A.J. Brown chose TEVA for his presentation. TEVA is a pharmaceutical company based in Israel with a market cap around \$9 billion. A.J. described how he uses TEVA to generate income on a regular basis with his options trading. TEVA works for A.J.'s process because it moves in a fairly consistent range. He then describes a process by which he sells a Put option and buys a Call option to generate income from decay of the time premiums.

Bio:

A.J. Brown was born and raised just outside of Washington, D.C. He attended the University of Virginia in Charlottesville, VA, where he graduated with two engineering degrees — mechanical and electrical — and a minor in commercial business. A.J. then pursued graduate studies at the University of Arizona before becoming a marketing strategist employed by several large corporations. For over three years, A.J. diligently recorded his observations and interpretations of the day's markets. Fascinated with the possibilities that options trading offered, A.J. took on a challenging experiment in February of 2004, in which he started with \$5,000. One year later, after only trading options, A.J. turned that \$5,000 into \$376,000. At that point, A.J. founded the TradingTrainer.com community where beginners and experts alike could come together to work with A.J. in making significant profits from their investment dollars.

The Option Professor (CRL)

Summary:

The Option Professor chose Charles River Laboratories International, Inc. (CRL) which is laboratory services company based in Wilmington, MA with a market cap almost \$12 billion. The Option Professor starts his analysis by pointing out that biotech has been turning around recently and after the large drop that CRL has had over the last few months, anyone who's going to get out of a position on this stock has probably already done so. He also points out that the company is profitable and projecting further growth. Additionally, The Option Professor explains technical reasons why he sees a possible turn to the upside for this stock.

The Option Professor has over 35 years experience, he is a graduate of Boston College and trained at Options Institute At The Chicago Board Options Exchange (CBOE). He has traded thousands of option contracts in all market conditions and has spent year training other options traders to do the same.

Sunny Harris (KDP)

Summary:

Sunny Harris chose Keurig Dr Pepper Inc. (KDP) which is a non-alcoholic beverages company based in Burlington, MA with a market cap of around \$50 billion currently. Sunny starts her analysis by pointing out that the volume on this stock has been steadily climbing and that the recent downturn in the overall market has not hit KDP as hard as most other stocks. Also, her SunnyBands indicator shows that it's likely near a low and she points out that the demand for coffee makes it a pretty secure business to be in.

Marina Villatoro (AMZN)

Summary:

Marina Villatoro chose Amazon (AMZN) which is based in Seattle, WA with a market cap of over \$1 trillion. AMZN's recent stock split is the initial reason for Marina's bullishness and points out that this will allow for smaller investors to begin acquiring the stock. She also points out that even as big as it is, AMZN still has a lot of room to grow, both into new markets like where she lives in Guatemala and bring more small businesses into their marketplace.

Anka Metcalf (AMZN)

Summary:

Anka Metcalf also chose Amazon (AMZN) which is based in Seattle, WA with a market cap of over \$1 trillion. Anka points out that while stock splits make no literal change to the value of the company, this action is only taken when a company believes they have strong future growth potential. Anka shows the AMZN chart for the last 10+ years and points out various features in the price action; especially notable were the flagging consolidation period that lead to a surge early in the 2020 Pandemic, and more recently the consolidation range of most of 2021 and early 2022. Anka closes her analysis by explaining how more recent moves indicate to her the likelihood of progression to new highs for AMZN over the next several years.
